INFORMATION TO PERSONS WHO FILL IN THE FORM "CONTACT REQUEST" PURSUANT TO ART. 13 OF THE EU REGULATION 2016/679

This information is given to those who fill out the form "CONTACTS" pursuant to art. 13 GDPR 679/16 - "European regulation on the protection of personal data".

Types of Personal Data processed

Processing methods

Modalities of refusal to provide data

Data transfer

Data Retention Period

Rights of the person concerned
